MINUTES OF APRIL 6, 2016 PLAN COMMISSION:

Motion by Vivian Green, seconded by Mark Asleson to approve the minutes of April 6, 2016, Plan Commission meeting. Carried unanimously.

PUBLIC COMMENT:

1. **Discussion and possible action on a certified survey map for Sue and Keith Slinde, for property located at 2614 County Highway B, Stoughton WI 53589, combine the current 3 lots into 2 lots for Parcel #0611-332-9270-0, 0611-332-9290-6, and 0611-332-9311-0.**

2. **Discussion and possible action on a certified survey map application #9868 for Stephen Champagne, for property located at 2059 Rinden Road, Cottage Grove, WI 53527, for parcel #0611-112-8500-9.**

Motion by Mary Haley, seconded by Tom McGinnis, unanimously approved, to recommend approval of certified survey map with the following conditions:

1. The document is to be completed in accordance with S.236.34, Wisconsin State Statutes.
2. Rezone petition #10931 is to become effective and all conditions established are to be timely satisfied.
 - a. Recording of an approved CSM.
 - b. Recording of a joint driveway agreement.
 - c. Recording of a deed restriction.
 - d. No further residential development.

3. Owner's name on the CSM shall include his middle initial. Shall be shown as Stephen D. Champagne.
 4. Comments from the Dane County Surveyor are to be satisfied:
 - a. Correct the Range East from 12 to 11 in both the location heading at the top of sheet 1 and the beginning of the boundary description.
 - b. Consider centering the road right-of-way on the section line. Highway orders for this road beginning just to the east of this survey are ordered and centered on the section line.
 - c. Remove the work "dedicated" from the Owners' Certificate, as no dedications are present.
- 3. Discussion and possible action on a certified survey map application #9875 for James and Linda Link, 2987 Bosben Road, Deerfield WI, for parcel #0611-014-8001-0 and parcel #0611-014-8370-0.**
