Resolution to Adopt the Comprehensively Revised Dane County Zoning Ordinance

The Town Board of the Town of Pleasant Springs, Dane County, Wisconsin do adopt and resolve as follows:

1. The Town of Pleasant Springs desires to promote the health, safety, convenience and general welfare of the residents of the Town and to encourage planned and orderly land use and development.
2. The County Board of Dane County, Wisconsin has adopted a comprehensive revision of a zoning ordinance for the physical development and zoning of territory within Dane County.
3. The Dane County Zoning Ordinance may become effective in the Town of Pleasant Springs upon approval of the ordinance by the Town Board.

NOW THEREFORE, be it resolved that:

Pursuant to Section 59.69(5)(c), Wisconsin Statutes, the Town Board of Pleasant Springs hereby approves and adopts the Dane County Zoning Ordinance as described in Dane County Ordinance Amendment 2018-OA-20 and shall take all required actions to make the Dane County Zoning Ordinance applicable within the Town of Pleasant Springs.

This resolution shall take effect on the date of filing with the Dane County Clerk a certified copy of this resolution, together with a copy of the Dane County ordinance amendment 2018-OA-20, and associated zoning map for the Town of Pleasant Springs (both attached as Exhibit A).
