MINUTES OF THE November 9, 2022 PLAN COMMISSION MEETING

Motion by member Wieser, second by member Pitas, to approve the minutes of the November 9, 2022 Plan Commission Meeting. Motion carried unanimously.

1. <u>Discussion and possible action regarding a Site Plan Review submit by David and Tammie Smithback (Chris Miller, representative) for a relocation of a residential structure at 2671 Straus Drive, parcel #046/0611-123-9500-4.</u>

Chris Miller summarized the intent to raze the existing home after building a new residence approximately 150 away from the current structure. They will be leapfrogging the well but using the same well. The driveway will be in the same location, just extended.

Discussion was held.

Member Weiser moved to allow David and Tammie Smithback, 2671 Straus Drive, parcel #046/0611-123-9500-4, to relocate the position of a new residence to within 200 ft. of the

existing structure, with the teardown of the existing structure to be completed within 90 days of occupancy. Comstock seconded. Carried unanimously.
