

**TOWN CAUCUS –JANUARY 17, 2023-5:30 P.M.
TOWN HALL, 2354 COUNTY RD N (held as a hybrid meeting-in-person and
virtually via zoom)**

PRESENT: David Pfeiffer, Clerk/Treasurer Maria Hougan, and Town residents as listed on the registration sheet and in the minutes. Voice registration was called for those attending virtually.

Chair Pfeiffer called the Caucus to order at 5:30 p.m.

Nominations were opened for Supervisor #2.

Motion by Judy Olson, second by Walt Olson, to nominate Eric Olson, as Supervisor Seat #2.

Motion by Dick Green, second by Emanuel Stern, to nominate Larry Schuller as Supervisor Seat #2.

After calling three times for other nominations and hearing none, presiding officer Miller declared nominations for Supervisor #2 closed.

The process for drawing the ballot placement was discussed with the nominees.

Motion to adjourn by Kenneth Schuck, seconded by Jim Gamoke, to adjourn at 5:40 p.m. The motion carried unanimously by acclamation
