The City of Stoughton has applied to the Department of Natural Resources for a permit to place a walkway on the bed of the Yahara River. The project is located underneath the 4th Street Bridge in the SW 1/4, NE 1/4, Section 08, Township 05N, Range 11E, in the City of Stoughton, Dane County.

The City of Stoughton has proposed a trail project to enhance recreational opportunities and complete a corridor to provide safe transportation to its public developments. The City's existing and proposed public features are expected to lead to a significant amount of recreational users. Because of that, the City is proposing this trail as a safe way to connect cyclists and pedestrian users with the various recreational amenities and with the surrounding trail system. The trail will be placed through an existing box culvert that runs underneath 4th Street.

Code, and ensure that the required mitigation meets the standards in s. 281.36(3r), Stats. if the project impacts wetlands.
